Abstract: The presumption of innocence is perhaps one of the most ancient procedural warrants in criminal matters, being a constitutional principle, according to which, up to the final judgments of conviction, a person is considered innocent.

Regarding the legal nature, the presumption of innocence poses a number of problems. One of these problems is if you can discuss a relative or an absolute presumption, although it is clear that the presumption of innocence of a person can only be a relative one. However, the character of this presumption is relatively somewhat mitigated by the fact that overturning the presumption cannot be made solely by a judgment of criminal conviction, even if it can be substantiated by any evidence. Any other legal act, no matter how it comes, could lead to establishing a person's guilt.

Another issue is raised by the knowledge of non-compliance with the presumption of innocence of the sanction, as a result of its legal nature. Due to the multitude of acts whereby can be affected, the answer is different depending on the Act by which the person's presumption of innocence has been violated, aspects which will be treated separately.

The presumption of innocence is closely related to the concept of impartiality of the Court, in order to guarantee the presumption of innocence, there is the

article 6 paragraph 2 of the ECHR, according to which the representatives of the State to refrain from making public statements, having the effect that the defendant is guilty of committing certain criminal offences. This obligation does not imply, however, that the authorities refrain from informing the public about ongoing investigations, but must use formulations of that guilt does not result in individuals being investigated, using terms such as "suspect", "there is suspicion that", etc..

Abstract: The introduction of the principle of digressive proportionality in the distribution of seats to the European Parliament results from the very large variation in the population of the Member States. Limiting the total number of deputies while ensuring adequate representation of the smallest countries contributed to the adoption of the principle of European solidarity. According to it, more populated countries receive a smaller number of seats than that which would result from the division of proportional representation. This means that less populated countries gain at the expense of the more populated ones. But there is no recommendation stating who should be regarded as the more populated and thus who gains and who loses as a result of replacing the proportionality by degressive proportionality. The aim of the paper is an univocal division of the Member States between the gaining and the losing ones. It was achieved by the introduction of the balanced function which for the first time associates degressive proportionality with the classical concepts of fairness, i.e. equality and proportionality. Consequently we indicate which countries should transfer their seats in favor of the others. None of the methods previously proposed in the literature has such property.

Freedom and power as governance practices are in an opposite position and each of the two concepts may be considered as the remedy of the other. Along the evolution of history, society's political organization, mainly by its main institution, the state, was achieved more and more based on the perfection of state structure in relation to the natural and legal persons of the state and of some rigorous legal norms that established both their freedoms and rights and the obligations and limitation of power of the state organisms to act in the spirit of the legal norms. The name of rule of law itself indicates that the state exercises its political power based on legal norms by using the force of argument and not the argument of force.

In the context of creation the European Community area, but especially following the accession of Romania to the European community, the legislative reform became a necessity. From this perspective, with the change of Romanian civil legislation, both members of committee who participated in drafting the bill regarding the amending of the Civil Code, and the members of the special Committee, took into account the objectives set at European level by all Member States, but also took into account the happy experiences, or not, of those states that have gone through a similar process of reform.

As we find from reading the Civil Code in force, and following the conclusions arising from the debate of the special Committee established at legislative level, we can say that this process of reform of the civil rule was influenced and inspired by several community or extra-community national legislations such as the French, German, Italian, Spanish, Swiss, Brazilian and Canadian. We may firmly say that the dominant model in the process of amending the Civil Code was the Civil Code - Quebec province. Within those influences we outline in this material the amendments that are found in the Civil Code in force, amendments in matters of unworthiness of succession and the removal of its effects. The Law in force and the doctrine establish the unworthiness of succession as civil penalty, even if we found in the Civil Code of 1864, in the actual form of the code we identify under two forms, namely legal unworthiness and judicial unworthiness as it is found in art. 958 and art. 959 of the Civil Code. Although the source of inspiration is the text from Civil Code of Quebec, the institution of unworthy forgiveness was taken over incomplete due to excessive caution of Romanian legislator, leaving unresolved some existing situations in the real life. Therefore in this work we find some critical accents and the proposal of lex ferenda.

It regulates, among others, the contextual and formal conditions of the provisions for a death cause (Chapter III, "Enforceable law", articles 26-27). These concern those wills left by a foreigner (belonging or not to an EU member state), but who has his regular residence in a EU member state, but also by a citizen who is a EU member having his regular residence in a third country and who chose to apply the law of his citizenship to his last will provisions.

Abstract: In the second half of the fifteenth century and the early sixteenth century, the idea developed that Moscow had a unique religious and political mission as the successor to Rome and Byzantium. The earliest surviving formulation of this idea is probably that in a letter by the monk Filofei (Philotheus), the elder (starets) of Eleazarov monastery in Pskov, written in 1511. On this paper I shall outline how the "Third Rome" idea was rooted in Muscovite culture and how it emerged under the impact of the events of the fifteenth century. The link made in Muscovy between a state and a supposedly universal church had a direct antecedent in Byzantium. As the Byzantine Empire declined, the Eastern Church increasingly took on the aspects of a Greek national church rather than a universal church. At the same time, Byzantine messianism presented Constantinople as both the "New Rome" and the "New Jerusalem". On this paper I will try to present the continuity of the idea of Third Rome on the Russian society, especially on the communist period and after. This study is a research on the Russian history, fallowing the messianic idea of Third Rome - Moscow. The events from XXth century show us how the communist and post-communist society kept this idea and developed according with their own interests.

In the context of the current regulatory framework and utilizing a comparative approach, the present analysis starts with the concept and identifies the meanings of the term in the two judiciary procedure matters. Abstract: People's perceptions on air pollution could be critical for reducing exposure of individuals and can also encourage behaviour changes. The paper presents the results of public Air Quality (AQ) perception questionnaires developed in the RokidAir project (www.rokidair.ro) to empower the public to participate in and contribute to AQ-related environmental monitoring and decision-making processes, and to increase public awareness regarding AQ-related information. The research methodology was based on questionnaires as a tool for acquiring information on public knowledge and perception on air pollution. The specific objectives of the study were as follows: to obtain information from public on their perception of the AQ in Ploiesti and Targoviste urban areas where they live, work or study; to explore the public interest level in AQ-related issues; to analyze public views on what types of AQ-related information is useful for their daily life; to discover if and how the public obtains existing AQ information; to explore if public are interested in obtaining more detailed AQ information; and to identify if public are willing to change their behavior and avoid exposure to air pollution. The target group was general public interested in AQ-related issues, including both professionals and normal citizens who are interested in air quality related issues. The sampling procedure used typical method applied on investigations in exploratory analyzes. The results revealed that people have a good understanding of key-drivers of air pollution but exists an apparent disconnect between theoretic knowledge and willings in changes of individual behavior. The communication strategy of authorities in the field of air pollution must be essentially improved to obtain changes in the behavior of individuals, which will be the key-drivers for a long-lasting improvement in air pollution levels.

Abstract: Soil degradation by desertification has become a concern for specialists a few decades ago, when several areas of Africa, Asia, America and Australia recorded long droughts, which determined the accelerated, sometimes irreversible degradation of the soil layer.

Desertification has initially been considered a process specific to the arid and semiarid regions in the world. Later on, the United Nations Conference on Environment and Development (UNCED) of June 1992, organized in Rio de Janeiro, brought back into everyone's attention the importance of keeping desertification under control, launching a concise definition: "desertification consists in soil degradation in the arid, semi-arid and tempetate steppe areas, resulting from various factors, including climate variations and human activities".

In Romania, the regions in which the ratio between precipitations and potential evapotranspiration (P/ETP) is lower than 0.65 are considered vulnerable to soil degradation by desertification. According to this criterion, the southern and south-eastern parts of Romania (first of all Dobrudjea and the eastern side of Baragan) belong to the category of high risk desertification regions. The central part of the Western Plain is considered another vulnerable region.

The specific features of these regions include: high drought frequency; low afforestation degree; soil erosion caused by water and wind; the presence of the underground water layer very deep in the ground. As a result, the soil layer has suffered important modifications, such as: changes in the hydric regime; structure degradation in the higher horizon; enlargement of salinization and alkalizing processes; reduction of the useful edaphic volume; decreasing of humus and nitrogen contents, a.s.o.

In order to stop soil degradation enlargement by describication, a series of measures has to be taken, the most important measures being mentioned as follows: afforested areas settling and irrigations introduction.
